## **Definitions**

**Community Block Grant:** A combination of federal, state, and local funds used to support behavioral health services in Michigan.

**MDHHS:** Michigan Department of Health and Human Services

**Northern Michigan Regional Entity (NMRE):** The PIHP for Region 2, the 21-counties located in Michigan's northern lower peninsula.

## **Purpose**

The purpose is to define the criteria for making residency determinations or the funding of substance use disorder services

#### <u>Policy</u>

Residency will be determined by the NMRE and its Substance Use Disorder Providers unless otherwise indicated.

## A. Medicaid and Healthy Michigan Plan Residency Requirements

Residency for individuals requesting SUD services who are enrolled in Medicaid or Healthy Michigan Plan will be determined by the county of residence based on the MDHHS Medical Services Administration

# **B.** Community Block Grant Residency Requirements

Residency for individuals requesting SUD services paid with Community Grant Block funding will be ninety (90) days of residency within the NMRE region unless otherwise indicated in this policy.

# C. Exception to Community Grant Residency Requirements

Individuals who meet a priority population requirement as listed will be served with Community Block Grant funding without meeting the ninety (90) day residency requirement. This exception is for the residency requirement only for Community Block Grant funding. Priority populations include:

1. An individual who is pregnant;

- 2. An individual who is considered homeless;
- 3. An individual who has injected drugs within the past thirty (30) days;
- 4. An individual whose child has been removed from the home or is in danger of being removed from the home under the Child Protection Laws

When Community Block Grant exceeds regional demand, residency requirements may be waived.

Individuals who are incarcerated within the NMRE region may be served with Community Block Grant funding even if their last known residence is outside of the NMRE region. NMRE Community Block Grant funds may not be used for individuals with a last known address outside of the NMRE region whose placement in the NMRE region is due to a boarding or bed purchase arrangement with a county entity located outside of the NMRE region.

Requests for exceptions to the Community Block Grant Residency requirements may be made to the NMRE. Consideration for an exception to policy will be made on a case-by-case basis.
